### **CELEBRATING A WORLD FIRST FOR SCOTLAND**

It was on the 16<sup>th</sup> of April 2016, the 270<sup>th</sup> anniversary of the Battle of Culloden, that we launched our community share offer. Over the next frantic months, investment poured in from all over the globe with investors originating from some 30 different countries! Our initial funding target of £1.5 million was quickly passed as people got behind our vision to create the world's first community-owned distillery. When the initial share offer eventually closed at noon on the 8<sup>th</sup> of July, the final amount raised was over £2.5 million – breaking the UK record for a community-funded project! Now with more than 2,500 investors/owners involved, it is up to the team here at GlenWyvis to make this collective dream a reality.



### **NEW CHAIRMAN BRINGS AUTHORITY TO THE ROLE**
